Project Background

In response to the priorities of the Government of Pakistan on poverty reduction, the World Bank in close consultation with Government of Balochistan (GoB) and relevant stakeholders have designed the Balochistan Livelihoods and Entrepreneurship Project (BLEP) focusing on improving livelihoods of rural communities by promoting employment opportunities and sustainability of enterprises in project Districts. The project will be implemented in eight districts of Balochistan, including Killa Abdullah, Killa Saifullah, Chagai, Sherani, Pishin, Mastung, Zhob and Nushki and will benefit rural households to promote livelihoods through enterprise development and job creation.

The project will predominantly target communities based in areas affected by a protracted refugee situation. The project is likely to gain benefits for the communities in selected districts, having reliance on enterprises related to various sectors, with a priority on Agriculture, Livestock, Mines, Minerals, Handicrafts, Small Industries, Ecotourism and Forestry. In addition, the Project will have specific benefits for people living in these geographical locations through improved facilities development. The Project has three main components and will be implemented during the course of 5 years. It is financed by the World Bank and executed by Planning and Development (P & D) Department Balochistan.


Objectives and Goals

The objective of the BLEP is to develop dynamic, internationally competitive private sector micro, small and medium enterprises (MSME's) by working directly at the firm level and improving the overall business operations, MSME's revenue and creating employment to undercut the impact of refugees' influx and extremism. Moreover, the primary prerequisite for such stabilization is a robust and competitive private sector resulting from a market-driven economic environment and enabling policies. These MSME's are expected to create employment opportunities for rural communities and achieve sustainability of enterprises in selected districts of Balochistan. The project will help local entrepreneurs and individuals to enhance profitability and income provision. These enterprises will help in making a significant contribution to reduction of poverty and uplifting the host communities in the eight districts of Balochistan through business opportunities. The BLEP will offer a comprehensive set of interventions in technical assistance, training, certifications and standards, local and export marketing, and technology upgrades that strengthen SMEs and create a robust private sector. The primary goal of the project's value chain development activities is improving SMEs' revenue and creating employment opportunities.

Terms & Conditions for Selected / Shortlisted Suppliers / Service Providers

- 2. The registered / pre-qualified organizations will be preferred for inviting sealed financial bids / quotations
- 3. The financial quotations / bids should be provided within the specified time period
- 4. The rates must be inclusive of applicable taxes.
- 5. The rates shall be inclusive of delivery and installation of relevant items, materials and accessories at BLEP target districts including all means of transportation
- 6. The sealed financial quotations may / may not be opened in front of bidders
- 7. The retention money may be required in case of products / services warranty
- 8. The bank guarantee may be required in case of specialized / technical products and after sale services
- 9. BLEP Balochistan will not be liable to change Purchase / Work Order (once approved) if prices of supply and other materials will increase due to inflation or any other factor
