The qualification criteria for Refugee related Implementing Partner is as below:

- 1) Firms must be registered in FBR and Ministry of States & Frontier Regions (SAFRON), GoP.
- 2) Foreign Firms must have registration with the Economic Affairs Division (EAD).
- 3) Firm must have at least 15 years relevant working experience in Development sector;
- 4) Firms must submit any fifteen (15) verifiable evidence of market placement of their beneficiaries after completion of all its skill development / livelihood interventions.
- 5) Firm must have at least one (01) proof / evidences of living examples of any self-created & self-sustainable business models / enterprises in Baluchistan Province;
- 6) Firms must have at least Five (05) key experts having at least sixteen years of education with any HEC recognized Institutions (local / foreign) in specific area / field of training to be provided.
- 7) Firms must be registered with Government Qualification Awarding Body i.e. Technical Board or Technical Education & Vocational Training Authority i.e. at National or provincial level, Government of Pakistan for at least ten years (10) years.
- 8) The Firm must have at least five years (05) years working experience of skill development [competency based training (CBT) programs] in accordance with National Vocational Qualification Framework (NVQF) in which at least three (03) years working experience (contract duration) of skill development [competency based training (CBT) programs] in accordance with National Vocational Qualification Framework (NVQF) with Afghan Refugee Communities.
