Quotations shall be evaluated as per the following Criteria. Manufacturer /Dealer must be registered in FBR as an active filer. (Copy of NTN & STRN Certificate must be required) · At least 10 years' experience in supplying / manufacturing agriculture implants /machinery.(Copies of Contracts / Purchase Orders / supply Orders / Letters of Award etc must be required). Dealers must have a dealership certificate. (Copy of Certificate must be required that shall be verified by the Manufacturer). Must have turnover ofat least PKR 100 million Official/formal bank statement for current financial year must be required). Must have at least one office in Baluchistan Province. (Complete postal address and contact numbers must be required) Information regarding any litigation, current or during the last five years, in which the Bidder is involved, the parties concerned, and disputed amount (if any); (Affidavit at stamp paper @ PKR 100 must be required regarding any blacklisting &litigation, current or during the last five years, in which the Bidder is involved, the parties concerned, and disputed amount). 4. Quotation must be along with detailed Company's Profile and adequate technical documentation (catalogue / brochure) complete in all aspects. 6. 
